I Lokacije i prenosni kapaciteti za TETRA mrežu

1. Bazne stanice TETRA sistema na koje se odnosi ovaj Ugovor nalaze se na sledećim lokacijama:

2. RDC obezbeđuje Ethernet vezu putem VLAN-a brzine 1 Mbit/s od navedenih lokacija do tačaka povezivanja RDC-a i NOC-a WM-a (RTV Dom i Sjenica). Na Ethernet switch-u RDC-a na gore pomenutim lokacijama će biti opredijeljena 2 porta za potrebe razmjene saobraćaja sa baznom stanicom.

II Prenos saobraćaja između RDC mreže i NOC WM

1. RDC obezbeđuje prenos saobraćaja preko postojećeg linka RTV Dom - Nova zgrada Uprave Policije.
WM će pribaviti dozvolu od Uprave Policije za korišćenje ovog linka.
Tačka razgraničenja u ovom slučaju je port na switch-u u zgradi Uprave

I Locations and transmission capacities for TETRA network

1. Base stations of TETRA system which this Agreement refers to are placed at the following locations:

2. RDC provides Ethernet network via VLAN, having the speed of 1 Mbit/s from each of the specified locations to the points of connecting RDC and NOC WM (RTV Dom and Sjenica). RDC's Ethernet switch at the above locations shall be provided with 2 ports for the needs of exchanging traffic with the base station.

II Transmission of traffic between RDC network and NOC WM

1. RDC provides the first transmission of traffic over the existing link RTV Dom - the new building of the Police Department.
WM will obtain permission from the Police Department to use this
